### Background

Dr. Kumar comes to the California Department of Public Health (CDPH) with more than 25 years of experience in the New York State Bureau of Dental Health, where he served as director of oral health surveillance and research and as director of the New York State Dental Public Health Residency. He has held the positions of state dental director and acting director since 2009 and is responsible for developing the first comprehensive state oral health plan for New York.

On June 8, 2016, Governor Jerry Brown announced that Dr. Kumar will serve as California's new state dental director which is a major achievement to establish this position for the state's oral health program and access to care planning goals.
